## Objectives:

We are committed to complying with all applicable legal and other requirements related to safety, environment, energy, sustainability, and quality. In addition, we aim for continuous improvement of our performance in the following two areas:

### 1. Safety and Well-being

- Prevent personal injury and material damage, and strive for zero accidents with lost time by promoting desired safety behavior and collaborating with partners who prioritize safety.
- Ensure 100% compliance with safety procedures during execution.
- Build resilience to stress through structured training and workshops on mental resilience and time management.

### 2. Transport & CO<sub>2</sub> Emissions

- By 2026, have a clear plan to reduce Scope 3 CO<sub>2</sub> impact from outsourced transport through optimized logistics and the use of logistical hubs.
